Within International Relations, education has received little attention as factor that shapes identities. To address this shortcoming, this dissertation frames education as a mechanism that imparts understandings of the world and our place within it, while cultivating skills that enable us to assume social, economic and political roles. The author traces education in England and France from 1870 until 1914, where education was consciously deployed for the purposes of identity construction against a backdrop of imperial expansion. This places us in a position to observe how empire was taught and how the élite were trained for imperial administration. This dissertation offers a novel, replicable approach to international politics and contributes to a burgeoning literature on identity. It also answers a call within the constructivist paradigm for greater insight into internal processes behind identity construction while strengthening constructivism’s explanatory contribution.

RESEARCH INTERESTS

European Security Cooperation

Efforts to carve out a distinct strategic role for the European Union in the new millennium have reinvigorated research on European security cooperation. Current literature tends to be descriptive in nature, driven by definitional considerations, or focused on fleshing out institutional dynamics. While worthwhile, these themes leave open an agenda that investigates the nature of European-level cooperation during power transitions and crises among Great Powers. Along these lines, my contribution seeks to unpack the various incentives and constraints shaping European security cooperation with an eye toward:

- Sino-European strategic relations;
- Atlantic relations, including the impact of Washington’s ‘Asian pivot’;
- The ongoing development of ‘Normative Power Europe’;

- The impact of cost, culture, and capabilities on the militarization of European security and defense cooperation.

Education and the Study of Identity, International Politics and Foreign Policy

My research of education as a mechanism for identity construction draws upon my dissertation, and I am widening the lens to consider education's impact upon nationalism in France and England prior to the First World War. The agenda also includes German education in the late 19th and early 20th centuries. German authorities likewise used their schools to cultivate a shared identity through a curriculum laced with nationalist and patriotic themes during a period of colonial expansion.

In addition, I consider education in different contexts so as to demonstrate the explanatory value of the mechanistic approach to education and identity to international politics. These opportunities include:

- Education, the Cult of the Emperor, and the Remilitarization of Japan after the First World War;
- Education, US foreign policy, and the demilitarization of Germany and Japan after World War II;
- Education and identity construction at the European Community/European Union level;
- Education and identity construction in post-conflict societies (e.g. former Yugoslavia, Rwanda, Afghanistan and Iraq).

Additional Research Topics

- European politics, economics and history, including European integration, EU policymaking and institutions, as well as social and political change in modern Europe.
- The rise of China and its consequences for Europe and the United States, including Chinese foreign, strategic and economic policy, in addition to China's impact upon the environment and energy sector.
